Re: Clinical Academic Training Posts at Queen's University

Queen's University Belfast in partnership with the Northern Ireland Medical and Dental Training Agency (Northern Ireland Postgraduate Deanery) and the Belfast Health and Social Care Trust provide Clinical Academic Training opportunities in research and education. These posts have been created as part of Modernising Medical Careers/National Co-ordinating Centre for Research Capacity Programme of Integrated Academic Training. They offer candidates a comprehensive experience in clinical academic dentistry alongside internationally recognised clinicians and researchers.

We are seeking highly motivated, enthusiastic individuals wishing to excel in both clinical and academic training and who have the ambition to be the next generation of leading academic clinicians. Applications are now invited for Academic Clinical Fellowship (ACF) and Academic Clinical Lecturer (ACL) posts in Dentistry.

Applicants for ACF posts should have completed Foundation Training and have a minimum of 2 years' experience in Hospital Dentistry to DCT2 level (or above) at the time of appointment. Applications from existing Specialty Registrars in Dentistry are also invited. The ACF post is normally for 2 years and will be funded at DCT3 level or above, dependent on existing experience. During this period the ACF will participate in clinical training with 25% of their time to undertake research at QUB. They will prepare an application for an externally funded clinical research training fellowship to undertake a PhD. Trainees who already have research experience will also be considered for ACF posts.

The ACL post, normally for 3 years, attracts an NTN(a). Those appointed at ACL level will already have a postgraduate degree (PhD) or be within three months of submission. They will finish their clinical training while continuing academic development at post-doctoral level with 50% research time at QUB.


Trainees should review the Job Description for the specific criteria. Core clinical competencies will be gained as necessary through access to the essential elements of the training curriculum. Clinical training offers a wide range of opportunities in programmes that have a strong track record in specialty training and academic activities.

For candidates who already have a PhD in a relevant field but are early in their training, an individualised training plan may be possible.
