Practical Solutions to Current Conveyancing Issues

Conveyancing and Practice Management Seminar

Following a series of previous very successful seminars, the Institute of Professional Legal Studies is offering a new seminar on how practitioners can respond to current challenges in conveyancing practice.

This seminar will cover: the four 'pillars' of a purchase – how a purchasing solicitor can utilise the estate agent, financial adviser and surveyor; the implications of current practice in relation to the deposit; the Solicitors Accounts Regulations 2014 and how they affect completion; the implications of current practice in relation to the 'ten year' rule for Building Control certificates; complying with CML 'Safeguarding' requirements; Appeal Court decision in Capital Home Loans Limited v Hewitt and Gilpin; Eden (NI) Limited and another v Mills Selig; how to protect your client's conditional contract when acting in a new build; how to protect yourself if a developer retains apartments; 'old' new builds and repossessions- building agreements, the General Conditions of Sale; and costs – what we charge and what we can do. These issues will be addressed from a very practical perspective and there will be time for discussion and for questions raised by participants.

Simon is a partner in Murray Kelly Moore Solicitors and has extensive experience in domestic and commercial conveyancing. He was a member of the Council of the Law Society and is currently a member of the Law Society Conveyancing and Property committee. Ruth practiced as a solicitor before coming to the Institute, where she teaches conveyancing. She is a senior lecturer at IPLS. She was consultant editor of 'Residential Property Law in Northern Ireland' and is a contributing Editor to the Law Society's 'Folio' periodical.
