The School is a vibrant location for students as it is home to the First Derivatives Trading Room, the Chief Executives Club for Northern Ireland and the William J Clinton Leadership Institute.





Study Abroad students at Queen’s normally take three modules (classes) per semester. Modules are usually worth 20 credits each and students require 60 credits per semester. This equates into 15-18 US credits or 30 ECTS credits. If students require more credit for their semester or year abroad, they can opt to take an additional module.
