Actuaries are constantly in demand and their skills are continually included in highly skilled occupation listings. The Bureau of Labour Statistics predicts that employment of actuaries is expected to increase by 20% between 2018 and 2028. Actuaries primarily work in insurance and financial services, which are heavily regulated and require a number of statutory disclosures. In addition, with the growth in data science and Insurtech, new, more technology based opportunities are available to actuaries. Rather than automation being a threat for actuaries, these new tools will enable actuaries to help their clients make better decisions, which contribute to the positive outlook for actuaries in the long term.
