About the Collection:

Previously known as the Gibson-Massie Collection, the material was collected by the Belfast based, Scottish man, Andrew Gibson (1841-1931). Gibson and his family moved to Belfast in the 1880s where he worked as an agent for George and James Burns Limited, and the Cunard Steamship Company. As a book collector with a vast collection, Gibson became a Fellow of the Royal Society of Antiquaries of Ireland and then the Governor of the Belfast Library and Society for Promoting Knowledge (Linen Hall Library), where he played an instrumental role in the revival of the *Ulster Journal of Archaeology*, organising the second *Belfast Harp festival* in 1903, and the *Belfast Shakespeare* Festival in 1905.

Gibson's collection include the works of Robert Burns, Thomas Moore, and Allan Ramsey. Gibson also had an interest in the Freemasons of Ireland. The Freemasonry Collection (MS 26) is mainly composed of handwritten notices (copies) of newspaper advertisement that call upon the Masonic lodges to assemble for their activities.

The notices begin in 1759 and run up until 1799, amounting to over four hundred hand-written copies taken from prominent newspapers of the era: *Belfast Newsletter, Belfast Mercury, Belfast Evening Post*, and *The Northern Star.*

Andrew Gibson's collection of books and manuscripts were discovered when P. D. Massie purchased the derelict house of Gibson. Massie offered Queen's University Belfast the opportunity to purchase the collection and requested it to be called the Gibson-Massie Collection. The Library at Queen's University agreed and purchased the collection in May 1960. However, the collection was vast, so it was divided into three main areas of strength:

- 1) Thomas Moore Book Collection (Prefix of 'Moore/' in Library catalogue)
- 2) Gibson-Massie Collection (MS 37)
- 3) Freemasonry Collection (MS 26)

The entire collection is now held at the McClay Library, Queen's University Belfast, under the supervision and care of Special Collections and Archives.

MS 26 / A-AJ: Summaries

MS 26 / A / 1-61

A collection of handwritten notices copied from local newspapers, stapled together, and entitled 'Freemasonry in Ulster Towns and Villages, Advertisements, paragraphs, etc.'. They begin in 1759 and are in chronological order, covering regular occurrences and activities, such as funeral notices, announcement of Lodge meetings, and letters of thanks to ministers from Lodges for Sermons delivered to them. Many of the notices reference activities on, or related to, St. John's Day. The notices also reveal the close associations between Orange Lodges, Freemasonic members, and the Volunteers.

MS 26 / B / 1-37

A collection of handwritten notices copied from local newspapers, stapled together, and entitled 'Freemasonry 1791-1792'. They begin in 1791 and are in chronological order. The entries contain similar content as MS26 / A / 1-61, but also begin to reflect the political situation at the end of 1792. Many entries contain details of resolutions passed by lodges declaring their support and loyalty to King George III, the Constitution, and the Civil Magistrate.

MS 26 / C / 1-51

A collection of handwritten notices copied from local newspapers, stapled together, and untitled. They begin in 1792, are in chronological order, and detail similar occurrences as in MS26 / A and MS26 / B. They consist mainly of resolutions passed by Lodges at various meetings, most of which declare allegiance to King George III, the Constitution, and the Civil Magistrate, as well as support for parliamentary reform. It also contains a small number of notices relating to church services on St. John's Day, and a fake letter submitted to the *Belfast Newsletter* (MS26 / C / 39).

MS 26 / D / 1-74

A collection of handwritten notices copied from local newspapers, stapled together, titled 'Freemasonry. Genealogical, Biographical & Obituary'. They begin in 1794 and are in chronological order. They follow the same pattern as MS26 / A / 1-61 and contain accounts of Church sermons, notices of thanks to ministers, and announcements of resolutions reached by lodges at meetings - most of which confirm support and loyalty to King George III, the Constitution, and the Civil Magistrate.

MS 26 / E / 1-14

A collection of handwritten notices, copied from local newspapers, stapled together, titled 'Freemasonry, etc. Miscellaneous Notes' on the cover. Together they cover the period 1759-1886 by noting a wide range of events, including death notices, marriages, lodges of persons etc. Also included is an account of the laying of the foundation stone at the Belfast Poor-House, an entry reporting on appeals from workers in the Belfast cotton industry to the Earl of Hillsborough, and an extract of a letter relating to the marriage of Lord Kilwarlin (Earl of Hillsborough) to Mary Sandys.

MS 26 / F / 1-14

A collection of handwritten notices, copied mainly from local newspapers, stapled together, titled 'Freemasonry: General', on the cover. They begin in 1783 and include accounts of events and sermons on St. John's Day, notices relating to Lord Kilwarlin's election as Grand Master of the Free and Accepted Masons and lists of Lodges in Ireland. Advertisements for plays and entertainment evenings are also included.

MS 26 / G / 1-63

A collection of handwritten notices copied mainly from local newspapers, stapled together, and entitled 'Free-masonry in Belfast, Advertisements, paragraphs, etc, Till 1790'. The Belfast and Orange Lodge N°257 feature heavily throughout. There are also advertisements for plays and entertainment evenings, as well as some advertisements of newly published books for sale and where they can be bought.

MS 26 / H / 1-51

A collection of handwritten notices, copied mainly from local newspapers, stapled together, and dating across the 18th century. Some entries from *The Hibernian Magazine* and *The Gentleman's and London Magazine* are included. Also contained are a number of extracts from the Dictionary of National Biography of 1890, as well as an entry from British Museum Catalogue related to Mrs. Elizabeth Griffith and Richard Griffith Esq. It notably begins with the lineage of Hugh O'Neill, Prince of Tir-Owen, in 388 AD., the McDonnell's of Antrim, continuing with the lineage of the Hill family of Hillsborough, beginning in 1400.

MS 26 / I / 1-45

Forty-five hand-written pages, stapled together, of an extensive review of 'Bro. Pennell's revised edition (1730) of James Anderson's *Book of Constitutions of the Free-Masons* (1723) for use in Ireland, see MS26/H/17. It details the changes to the original work of Anderson by Pennell for the Irish edition. A proposal on page seven states: 'We now propose to follow him through the Book, and indicate such changes or repetitions as seem due to the circumstances of the Irish fraternity, beginning with the frontispiece'. The author of these forty-five pages is not indicated, however, a reference on page forty-two shows that it is post-1872.

MS 26 / J / 1-37

Thirty-seven pages, stapled together, of an incomplete hand-written transcription of *Caementaria Hibernica*, *Irish Consititutions* (1895) by William John Chetwode Crawley.

MS 26 / K / 1-63

A collection of handwritten notices copied from local newspapers, mainly from the *Northern Star*, and entitled 'Orangeism'. They relate mainly to the rise of the Defenders, their clashes with the Peep-O-Day Boys, and the formation and general activities of the Orange Order.

MS 26 / L / 1-8

A collection of handwritten notices copied from local newspapers, stapled together, and entitled 'Clubs in Ireland and Commemoration in Belfast of Revolution of 1688'. The collection begins with reference to the Patriotic Club of Newry. Of note also is MS26 / L / 05, a full account of the 'Commemoration of the Glorious Revolution of 1688' from the *Belfast Newsletter*, 12-15 February [1788]. Also included is an 'Extract of a letter from Comber Feb 14' which describes a commemoration of the Glorious Revolution in Comber.

MS 26 / M / 1-42

Forty-one handwritten pages stapled together (the forty-second page is blank except for a title, Chapter 1). No author named. Possibly the introduction from a book on Freemasonry and Orangeism. The pages refer to various sources to trace the history of Freemasonry, particularly in Ireland after the 'Glorious Revolution', and explores links with the formation of the Orange Society.

MS 26 / N / 1-19

Seventeen handwritten pages, two of which are written on both sides. Two extracts from Richard Lilburn's *Chapters in the History of Orangeism* – a history of the Orange Order published in the *Belfast Weekly News* – are copied. They discuss 'The Conflict of Lisnagaed' and 'The Battle of the Diamond' and Gibson's own annotations and comments are included. Also included are notes from Philip Harwood's *History of the Irish Rebellion of 1798* (1844), notices from the *Belfast Newsletter* and the *Northern Star* in 1795, and a two-page miscellaneous list of lodges, names and references.

MS 26 / O / 1-20

Original newspaper clippings from the *Belfast Newsletter* relating to the origins and history of the White Linen Hall building. The articles discuss the Industrial Exhibition of 1895, the foundation stone laid in 1783 and the significance of the word 'Orange' attached to Lodge N°257 of Belfast – the Orange Society was not formed until 1795 in Co. Armagh

MS 26 / P / 1-30

A collection of handwritten notices copied from the *Belfast Newsletter*, stapled together, and entitled 'White Linen Hall, 1782'. The articles include letters and accounts of meetings discussing various matters relating to the linen trade in Ulster. Issues discussed include the establishment of a white linen market in Belfast and the construction of the Lagan Navigation Canal.

MS 26 / Q / 1-2

Handwritten revised proofs of 'Chapter I: Introductory, Orange and Masonic' to what appears to be a publication that Gibson was preparing relating to the Orange and Masonic institutions. Contains annotated newspaper clippings discussing previous work by Richard Lilburn and Andrew Gibson on the topic, and which also reference related letters in the *Belfast Newsletter* and *Belfast Evening Telegraph*.

MS 26 / R / 1-14

Handwritten revised proofs of 'Chapter II, 1781' to what appears to be a publication that Gibson was preparing relating to the Orange and Masonic institutions. Discusses earliest mentions of freemasonry in Belfast in local newspapers at the time and also the significance of the Festival of St. John celebrations on 24th June and 27th December. Refers to other publications including *Masonic Facts and Fictions* (1887) by Henry Sadler and *Caementaria Hibernica* (1895) by W.J. Chetwode Crawley. Contains annotated newspaper clippings relating Masonic activity in Belfast during the late eighteenth century, especially of the freemason Orange Lodge of Belfast, N°257.

MS 26 / S / 1-23

Handwritten revised proofs of 'Chapter III, to be a publication that Gibson was preparing relating to the Orange and Masonic institutions. Contains annotated newspaper clippings of Masonic activity in Belfast during the late eighteenth century, as well as references to other sources – for example, George Benn's *History of the Town of Belfast* (1877), Joy's 'Historical Notices' and Henry Sadler's *Masonic Facts and Fictions* (1887).

MS 26 / T / 1-21

Handwritten revised proofs of 'Chapter IV, 1783' to what appears to be a privately printed and distributed pamphlet that Gibson was preparing relating to the Orange and Masonic institutions. Annotated newspaper clippings of Masonic activity in Belfast during the late eighteenth century are included. Particularly from the *Belfast NewsLetter* as 'no other newspaper was published in Belfast at the time in question'. Also included, is an account of the laying of the Foundation Stone of the Belfast White Linen Hall, quotes from Benn's 'History of the Town of Belfast', and a biographical sketch of John Brown, Sovereign of Belfast.

MS 26 / U / 1-23

First page is entitled Chapter V, 1784. These are mostly handwritten revised proofs culled from newspaper accounts of Masonic activity in Belfast, in the late eighteenth century. Perhaps noteworthy for the range of activities partaken, and the names of those mentioned.

MS 26 / V / 1-26

First page is entitled 'Freemasonry or Orangeism in Belfast in the year 1783?' Most of these pages have been printed, probably for private circulation only, by the author Andrew Gibson, at the office of the Belfast *NewsLetter* in 1896. However, this material is now to be used as the basis for an enlarged book or pamphlet, using additional information. Like what has been written previously.

MS 26 / W / 1-12

First page is entitled 'Freemasonry or Orangeism in Belfast in the year 1783?' this is essentially what has already appeared, although they are corrected pages, not proofs, and refers only to the information gathered apart from the three letters.

MS 26 / X / 1-10

First page is entitled 'Freemasonry or Orangeism in Belfast in the year 1783?' this is essentially what has already appeared, although they are corrected pages, not proofs, and refers only to the information gathered apart from the three letters. If MS26 / W / 1-12 and MS26 / X / 1-10 were collated together, one would probably have the corrected printed version of MS26/V/1-26. Page, one has handwritten upon it, 'incomplete'.

MS 26 / Y / 1-5 A few pages, some handwritten, some printed, all relating to Belfast Freemasonry in the late eighteenth century, probably proofs for the pamphlet, 'Free-masonry or Orangeism in Belfast in the year 1783?'

MS 26 / Z / 1-10 A collection of ten miscellaneous handwritten pages, with reference to Freemasonry.

MS 26 / AA / 1-54 A folder entitled 'Collectors' and containing fifty-four pages with music collector's addresses. These relate mainly to 'The Ballad Company', in Arthur Lane, Belfast, and to W.K. Gibson, Solicitor, the son of Andrew Gibson.

MS 26 / AB / 1-42 A folder entitled 'Mail Check' and containing forty-two letters relating to the business of The Ballad Company. In essence, reminders to clients

MS 26 / AC / 1-24 A folder entitled 'Attention' and containing twenty-four letters, relating to the business of The Ballad Company. In essence, reminders to clients, perhaps of a more urgent nature.

MS 26 / AD / 1-27 A folder entitled 'General' and containing twenty-seven letters, relating to the business of The Ballad Company. Mostly clients canvassing The Ballad Company's view upon their songs.

MS 26 / AE / 1-31 A folder entitled 'Amalgamated Publicity' and containing thirty-one letters, including cheques and telegrams, relating to the business of The Ballad Company. This is mainly correspondence relating to the sale of copies of songs.

MS 26 / AF / 1-18 A folder entitled 'J.D. Markey' and containing eighteen letters, relating to the business of The Ballad Company. This is mainly correspondence relating to the sale of orchestration of songs.

MS 26 / AG / 1-7 A folder entitled 'Correspondence with leading people' and containing seven letters, relating to the business of The Ballad Company. Mainly promoting the business of The Ballad Company.

MS 26 / AH / 1-128 This appears to be an index to a collection of Irish Melodies, although there are references to the 'Airs and Melodies familiar to the Highlands of Scotland'.

The first card is entitled, 'Irish Melodies, Eighth Number, London'. These are cuttings; the sources are not identified.

MS 26 / Al / 1-4 These are four A3 pages folded together, containing a listing of The Caledonian, and the different editions.

MS 26 / AJ / 1-4 Thirty-seven hand-written pages, stapled together, entitled 'Caementaria Hibernica. Being the Public Constitutions that have served to hold together the Freemasons of Ireland. Fasciculus Primus 1726-1730'.

MS 26 / A / 1-61 'Freemasonry in Ulster Towns and Villages' Summary:

A collection of handwritten notices copied from local newspapers, stapled together, and entitled 'Freemasonry in Ulster Towns and Villages, Advertisements, Paragraphs, etc.'. They begin in 1759 and are in chronological order, covering regular occurrences and activities, such as funeral notices, announcements of Lodge meetings, and letters of thanks to ministers from Lodges for sermons delivered to them. The focus is on Lodges from the north Down, south Antrim area, with reference to those in mid-Ulster. Many of the notices reference activities on, or related to, St John's Day. The notices also reveal the close associations between Orange Lodges, Freemasonic members, and the Volunteers.
