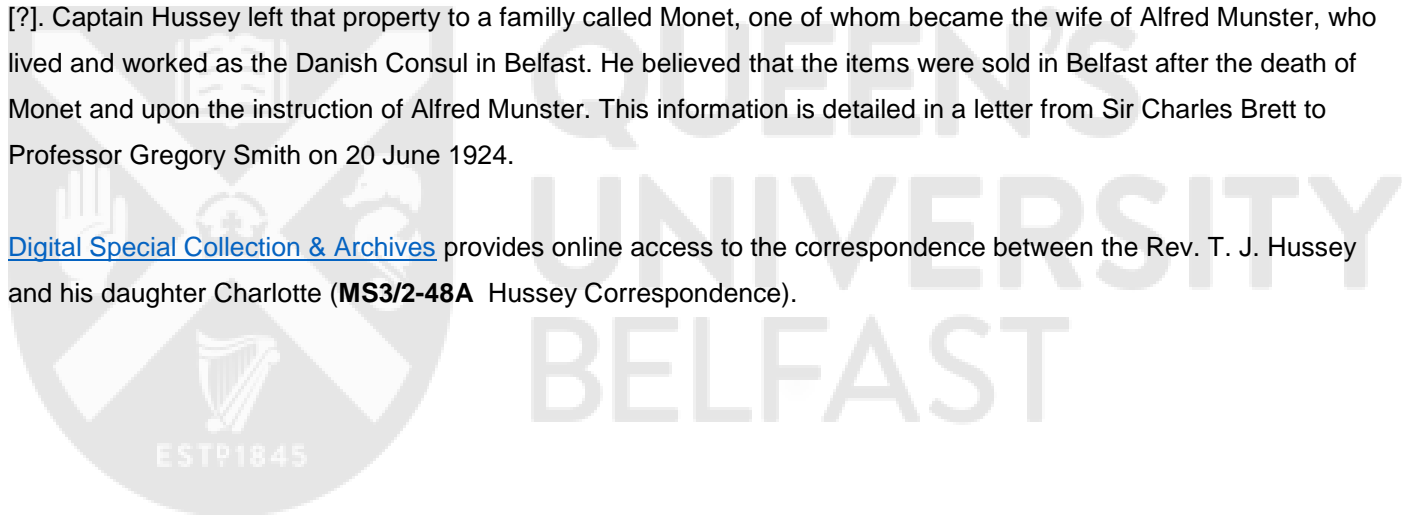
About the Collection:

This small collection of miscellaneous papers and documents was donated by Belfast solicitor, Sir Charles Brett (1839 - 1926), to the University Library on 20 June 1924. The collection was purchased by Sir Charles Brett on 29 March 1886 at Belfast (J. H. Smyth & Co., Auctioneers).

The collection consists of a variety of material, mainly of antiquarian interest, including books, extracts, manuscript, and other documents relating principally to early English civil and ecclesiastical law, land and/ or property in Yorkshire, c. 1220 – c. 1600, and Wakefield, c. 1763 – 1824, and the observations of the Rev. T.J. Hussey on English birds, c. 1828. This collection is also notable for a series of correspondence between Hussey and his daughter, Charlotte, during a stay in Aleppo, Syria from 1779 – 1780 and an unexecuted grant of tithes, c. 1145 – 1153 from the Archbishop of Mainz. The collection is divided into Sections A, B, C and D.

Brett believed the 'Hussey Manuscripts' came to Belfast through a Captain Hussey. He owned a property in Baugher [?]. Captain Hussey left that property to a family called Monet, one of whom became the wife of Alfred Munster, who lived and worked as the Danish Consul in Belfast. He believed that the items were sold in Belfast after the death of Monet and upon the instruction of Alfred Munster. This information is detailed in a letter from Sir Charles Brett to Professor Gregory Smith on 20 June 1924.

"The tractors...consisted of two pieces of metal about three inches long, seemingly of brass and iron, and were quite similar to the modern horse-shoe nail, being rounded at one end and pointed at the other. One side was half round, while the other was flat, with the name 'Perkins' Patent Tractors' stamped thereon...Benjamin Douglas Perkins...opened an office at 18 Leicester Square—a house formerly occupied by John Hunter." Notification by Henry archbishop of Mainz (1) of an agreement between Henry abbot of St. Alban in Mainz (2) and the abbot of Eberbach (3) relating to a grant by the former to the latter of "salic" land belonging to the church of St. Alban and of the chapel of ... with a decision of the archbishop that tithes of the land which was uncultivated at the time of the grant shall be paid to the church of St. Alban. 1145 - 1153

1. Henry I (Felix) archbishop of Mainz, 1142-1153. See Gallia Christiana, V, col. 470-471.
2. Henry I abbot of the Benedictine abbey of St. Aalban, Mainz, 1145-1150.
3. Cistercian abbey (also called Erbach) two miles down the Rhine from Mainz. Ruthardus the first abbot ruled 1135-1163.

This document has been trimmed at the top and bottom for use as the inner lining of a book cover. The title of the book is written on the dorse of the deed as follows:-

Liber Sancte Marie in Eberbachh scilicet Ysaye prophete Iheronimi exposition super dimidiam partem.

The writing of a number of the lines has been erased. Possibly the document was rejected owing to the interlineations on the last surviving line and a fresh copy made for execution. Its use as part of a book cover is very little later than its own date.

Preamble to the decision of the Official of the Archdeacon of London (to whom the cause was committed by the Official of the Court of Canterbury by commission dated at London, 5 February 127[9-80]) in a dispute between the parishioners of St. Sepulchre without Newgate, London, and the Prior and Convent of St. Bartholomew Smithfield, London, and the rectors of the said parish, which originated in the recent visitation of the city of London by J[ohn Peckham,] archbishop of Canterbury.

This document is mutilated at the bottom and on the right-hand side. Amongst the complaints are the following:-

The Prior and convent exact a candle from each dead person brought to the church and 11/2d. from each child baptized; they have carried away a portiforium and certain organs from the church.

The portion that survives contains the expenses of mowing the meadow at Cowlyng, the costs of the autumn ("Northfeld" and "Whitefeld" being mentioned), the carriage of firewood and the cost of repairs within the castle. 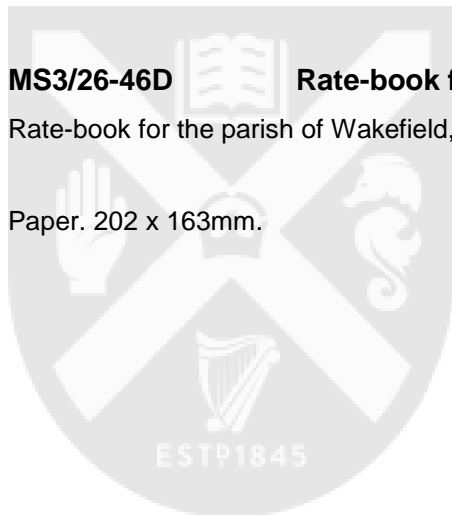
