The Northern Ireland Accountancy Milkround is the recruitment term for the process of advertising and selecting graduates into training contracts supported by Chartered Accountants Ireland (Ulster Society) at **www.charteredaccountants.ie** The NI organisations who participate in this Milkround have all agreed to the process defined in the **Graduate Recruitment Code of Practice 2015**. Additional Chartered Accountants Ireland training contracts for NI are advertised after the NI Milkround has taken place and many of these vacancies will appear on our website from February 2016. Note: The NI Milkround should not be confused with the Milkround.com student website.

Students from any degree discipline can apply for an accountancy training contract.
