UK first for actuarial students

A new society for actuarial students and those with an interest in the profession was launched at Queen's last month.

The first of its kind in the UK, the Society of Northern Ireland Actuaries (SoNIA) directly addresses the issues of employer engagement, student employability and innovation in the delivery of a top-class degree.

Around 40 new actuarial students pass through Queen's every year.

Colin O'Hare, President of the Society and Programme Director for the actuarial science degree at Queen's, said: "SoNIA not only offers employers the opportunity to engage with and

learn from academics who are working at the cutting edge of actuarial research, but also provides an opportunity for students to develop the necessary business awareness skills that can sometimes be difficult to teach in the lecture theatre.

Funded by Invest NI, SoNIA will offer a platform for local actuaries to provide their opinion on issues from pensions to investments and beyond. For students, it will offer an unrivalled opportunity for networking, professional development and engagement with industry.

Supported by the Institute and Faculty of Actuaries, the inaugural event took

place on 7 February, and was attended by president of the actuarial profession, Jane Curtis and Northern Ireland's Enterprise Minister Arlene Foster.

Queen's to boost job creation with new course

The Minister of Enterprise, Trade and Investment has just launched a new course at Queen's which could help attract investors to Northern Ireland by producing a new generation of software developers.

The MSc in Software Development at the School of Electronics, Electrical Engineering and Computer Science offers 60 places and is open to all graduates including those from non-IT disciplines from September 2012.

Minister Arlene Foster said: "The launch of the MSc in Software Development at Queen's is great news for Northern Ireland and the economy, as it is addressing the current shortage of software developers here. We know that an increase in the number of software developers available is an attractive prospect for companies considering investing here."

Course Director, Dr Darryl Stewart from the School of Electronics, Electrical Engineering and Computer Science, said: "The MSc in Software Development at Queen's is available to those who haven't had a previous background in information technology.

The conversion course is designed to develop the technical, analytical and professional skills required to take on software development roles.

John Healy, Director and Head of Technology Citi, said: "It is vital to international companies like Citi that we have a world-class University on our

doorstep providing quality graduates equipped with the skills we need. The launch of the MSc in Software Development demonstrates Queen's is listening to employers, and by doing this is ensuring global companies such as ours will continue to invest in Northern Ireland."
