#### PROGRAMME DETAILS

The primary degree within the School of Law is the LLB (Honours), which takes three years to complete.

In conjunction with the School of Arts, English and Languages, we provide a four-year degree in Common and Civil Law with a European language (French or Spanish), and in conjunction with the School of History, Anthropology, Philosophy and Politics, we also provide a three-year degree in Law with Politics.

All our degrees are Qualifying Law Degrees (QLD) recognised by Solicitors Regulation Authority and the Bar Council (for England and Wales) and The Law Society of Northern Ireland.

Legal skills are introduced and developed through the pattern of study and assessment for both the three and four-year degree programmes.

# (SINGLE HONOURS)

This Single Honours degree programme is taught over 3 years. Students take six modules per year, three in each semester.


In the first two years students undertake the compulsory subjects required for qualification giving them the opportunity to specialise in their final year when they study from a range of optional modules.

## LAW WITH LANGUAGES

At Queen's we offer two Joint Honours degrees that focus on Law and Languages – Common and Civil Law with French or Hispanic Studies.

This degree requires four-years fulltime study. Students who enrol on these programmes study the key components necessary for a Qualifying Law Degree in addition to their language modules.

These students spend one year (between their second and final year) studying in a University abroad (France, Belgium or Spain depending on their degree pathway).

Law represents two-thirds of the modules studied and French or Spanish the remainder.

The emphasis in the language modules will be on language and society.

## **LAW WITH POLITICS**

This three-year degree programme offers students the opportunity of combining Law with Politics. Law represents two-thirds of the modules undertaken and Politics the remainder.

Law and politics are integrally related to one another. The content of law is profoundly influenced by the political dynamics of government and legislatures. At the same time, politics is almost always structured and constrained by law.

The Law with Politics degree pathway offers students an excellent opportunity to understand this complex relationship. The pathway provides a foundation in public and private law, including the essential elements of a Qualifying Law Degree for legal practice. Meanwhile, students learn the fundamentals of the study of politics and pursue optional politics modules in accordance with their interests and career aspirations.

#### **ACCREDITATION**

All of the law degree programmes offered at Queen's are accredited by legal professional bodies in Northern Ireland and England and Wales.

#### **WORK PLACEMENTS**

Past students have gained work placements with organisations such as the Council of the EU, European Commission, European Parliament, United Nations (UN), Organisation for Security and Co-operation in Europe (OSCE), Council of Europe, and Thomson Reuters.

#### **ERASMUS EXCHANGE PROGRAMME**

Common and Civil Law with a European language (French or Spanish) students will spend a year at a university in France, Belgium or Spain.

#### **APPLICATION PROCEDURES**

Applications must be made through the Universities and Colleges Admissions Service (UCAS).



# **GETTING HERE**

#### CAMPUS AND LOCATION

Queen's historic campus is set in Belfast – the capital city of the UK region of Northern Ireland. It is less than one hour from London by plane and is easily accessible from other parts of the UK and Europe. Belfast has a modern transport infrastructure with two airports and daily flights to British and major European destinations.

Belfast offers something to suit every taste and budget. Historic pubs, stylish bars and cool clubs help to ensure Belfast lives up to its reputation as one of National Geographic's 'Places to Travel for Food in 2016'.

#### **SAFEST REGION IN THE UK**

Northern Ireland was named the safest region in the UK (British Crime Survey 2014). Queen's University is located in a quiet residential suburb, just a 15-minute stroll from Belfast city centre. Street crime and burglary rates in Belfast are much lower than in comparable European or American cities.

#### TRAVELLING TO BELFAST

Most major UK cities are within an hour's flying time from Belfast's two airports. Competition between budget airlines has been responsible in recent years for a dramatic reduction in fares.

There are dozens of flights a day to and from London and other destinations in Great Britain and beyond - at student friendly prices.

Fast ferry services from Belfast make multiple daily crossings to ports in England and Scotland.
