This degree will be of considerable relevance and interest to those who are already employed in criminal justice-related work in fields such as legal practice, government, non-governmental organisations, as well as equipping those who have just completed undergraduate degrees to develop the knowledge and skills to pursue criminal justice-related careers.



#### CONTENT

The LLM Criminology and Criminal Justice Programme takes an interdisciplinary approach to the study of crime and justice and draws on original staff research. Modules are rooted in relevant theoretical frameworks with a strong criminological focus and provide students with methodological training in addition to supporting the development of critical analysis and other transferable skills. Students are encouraged to develop a critical understanding of the criminal justice process and the practical operation of criminal law in a domestic and comparative context, and are given the opportunity to explore in-depth a particular criminalogical criminal justice-related issue through the submission of a dissertation.

#### **OVERVIEW**

The programme offers a unique approach to European Union and transnational law, aiming to generate comprehensive understanding of European and Global integration alongside approaches to federalism and multilevel governance: For years to come, EU expertise will be in high demand with government departments while the UK finds a new relationship to the EU. Legal practice will require expertise in EU law, whether or not the UK remains affiliated to the EU, in particular in specialisations such as commercial law and competition law. Graduates will be very well placed to excel in careers with EU institutions and organisations providing advice to national and regional governments in European matters.

Successful completion will open a wide range of career opportunities to graduates. Legal practice is increasingly informed by European matters, in particular in specialisations such as commercial law, competition law, employment law and welfare law.

Graduates would also be very well placed to excel in careers with the EU institutions or organisations providing advice to national and regional governments in matters of EU law and policy or in environmental governance: Global careers in both fields are also an option. This intellectually challenging programme is also the ideal starting point for an academic career.

#### **WHY QUEEN'S?**

The programme is unique in offering a 'law in context' approach to European Union Law, Transnational Law by teaching substantive law alongside legal theory and political and sociological approaches to federalism and multilevel governance: A high level of academic engagement is complemented by the opportunity to obtain subject specific placements in a competitive process.

Students can specialise in general EU topics and graduate with an LLM in EU Law and Governance or specialise in environmental and sustainability issues and graduate with an LLM in Environmental Law and Governance: Depending on success, students can either deliver a 60 credit (20 ECTS) dissertation or a module consisting of an internship and a dissertation at the same time:

#### **OVERVIEW**

The protection of human rights at the international level is a relatively new branch of law. Since World War Two there has been a huge growth in the number and variety of human rights standards set out in international treaties and in other so-called 'soft law' documents. These standards are not always fully implemented and the international mechanisms for trying to get them implemented are defective: This LLM provides students with an opportunity to gain an indepth appreciation of what has gone right or wrong and to suggest ways in which human rights could be protected more effectively so that human beings everywhere can realise their full potential.

The School has more than 25 years' experience in delivering an LLM in Human Rights Law and has constantly reviewed and revised what it offers as part of this degree, changing content to reflect the human rights issues that are currently most prominent: The focus is on international human rights law (including at regional levels in Europe, Africa and the Americas) with a concentration on the practice of human rights, especially in the contexts of discrimination, armed conflicts, terrorism and migration. The School's joint expertise is harnessed so as to provide a vibrant and relevant course which will stimulate the hearts as well as the minds of students who are taking it.

Human rights research and teaching has been carried out under the auspices of the Human Rights Centre at Queen's since 1990. The Centre has strong links with civil society organisations, statutory human rights bodies and international human rights institutions and networks, and organises a speaker series and a number of conferences annually. It participates in the Utrecht Network of Human Rights Centres and the Venice-based Masters in Human Rights and Democratisation and also has links with universities worldwide.

The Centre co-ordinates field visits to institutions dedicated to human rights issues in Belfast, eg NI Human Rights Commission and the Equality Commission for Northern Ireland. During the summer, the Centre organises a field trip to human rights institutions abroad, eg the European Court of Human Rights and the UN (Geneva).



#### **OVERVIEW**

The Masters in Law (MLaw) is an accelerated, fast-track, two-year, full-time, senior status postgraduate degree in Law. It is designed for graduates in a discipline other than Law who wish to obtain a Law degree for professional practice for England & Wales and Northern Ireland or in aid of other career goals.

#### CONTENT

The MLaw is offered on a modular basis. To complete the degree a total of 300 CATS points must be obtained. Twelve modules (20 CATS each) must be taken and a dissertation (60 CATS) must be completed. The structure is as follows:

#### **ASSESSMENT**

Modules are assessed by coursework assignments. In addition, students must also complete a 15,000-20,000 word dissertation, supervised by a member of academic staff with a research interest in the chosen topic.

#### **CAREERS**

This Masters programme is designed for UK non-law graduates, and for law and non-law graduates from other countries who wish to acquire a thorough grounding in Law. It is particularly attractive for those who wish to enter the legal profession, for whom it is an alternative to a graduate level CPE/GDL programme: By spreading study over two years of intensive postgraduate-level work, students gain a greater depth of understanding than is possible in one-year CPE programmes.

#### WHY QUEEN'S?

The MLaw is recognised by the Law Society and the Bar Council as a qualifying senior status Law degree for practice in Northern Ireland, England and Wales. Students hoping to practise in another jurisdiction should contact that jurisdiction's regulatory body.

# ADDITIONAL INFORMATION FOR INTERNATIONAL STUDENTS

International students wishing to apply to Queen's University Belfast (and for whom English is not their first language), must be able to demonstrate their proficiency in English in order to benefit fully from their course of study or research. Non-EEA nationals must also satisfy UK Visas and Immigration (UKVI) immigration requirements for English language for visa purposes.

Evidence of an IELTS\* score of 6.5, with not less than 5.5 in any component, or an equivalent qualification acceptable to the University is required. LLM International Business Law including Placement only: an IELTS score of 7.0 or equivalent is required.

#### **OVERVIEW**

The Juris Doctor (JD) programme is a Professional Doctorate, which is a partly taught and partly research-based Doctoral programme and is designed to provide our students with a world-class legal education, preparing them for the global and international environments in which they will be providing legal advice.

This three-year programme delivers a Qualifying Law Degree (QLD) to graduates from a discipline other than Law which will provide them with the necessary professional exemptions to allow them to apply for the professional stage in England and Wales and those further jurisdictions which allow for application on the basis on an English Law degree (eq North America and elsewhere).

#### CONTENT

The JD is taught at Doctoral level and includes multiple research-focused activities. In addition to the compulsory taught modules, students are required to complete a research portfolio and a 30.000 word dissertation. Modules include:

#### **ASSESSMENT**

Modules are assessed via written assignments and these may be in the form of a term paper, case comment, research essay, reflective portfolio, journal articles, or drafting/interpretation exercise: Oral performance in the seminars may also be assessed by way of an individual presentation in class along with a viva in the third year.

#### **CAREERS**

Graduates will hold a Qualifying Law Degree (QLD) which provides the necessary professional exemptions to allow holders to apply for the professional stage in several jurisdictions.

#### **WHY QUEEN'S?**

Students have the opportunity to apply to study at another university, from a selection of international study abroad partners with which the Queen's School of Law has an agreement, during the first semester of their third year.
