LLM International Business Law

This programme is designed to help you set the legal and regulatory regimes around international business and the global economy in the context of broader legal and socio-legal study skills. The LLM will prepare you for a career in the commercial sector, in business, government or in NGOs. You will be proficient in thinking about business on a global scale and the place of law, compliance, corporate social responsibility and trade in our societies.

The programme is open to applicants with a 2.1 or equivalent in Law or a cognate discipline (such as politics, geography, history, sociology, planning, business and commerce or management and finance). If you do not meet these criteria but have two years of relevant work experience or have completed a Masters elsewhere, you may also be eligible for admission.

Programme Structure

The LLM International Business Law with Professional Placement is two years in duration. The first year of the programme follows the traditional Masters programme model and is delivered through a series of taught modules. These taught modules will inform an extended dissertation submission on an original topic. Year two will feature a placement with a UK Law firm and students will be assessed on the completion of a related work-based project.

Compulsory modules

- Company and Commercial Law from a Comparative Perspective
- Issues in Corporate Governance
- Dissertation (15,000-20,000 words)
- Making Knowledge Work

Optional modules

- Finance, Competition and Law
- The Company in Society*
- Trade, Commerce and the Global Economy
- International and Comparative Competition Law
- Digital Financial Services
- Copyright in the Digital Environment

Compulsory methodology modules

- Approaches to Legal Research
- Legal Issues in the Governance of the Firm
- Methods of Legislation

*Note: students will be supported to find a work placement for year two which will be offered by Queen's University partners on a competitive basis.
