# RESEARCH ON GENDER AT QUEEN'S UNIVERSITY BELFAST

This report provides an overview of genderrelated research and publications by Oueen's University of Belfast staff and researchers. This mapping exercise complements the establishment of Queen's on Gender, a virtual hub that brings together leading academics from Queen's University who can provide an authoritative voice on gender, the many policy areas affected by gender, and a look at the ongoing work by civil society related to gender. Supported through the ESRC Impact Acceleration Account, the hub was established by the Centre for Gender in Politics at Queen's, under the leadership of the centre's codirectors, Dr Maria-Adriana Deiana and Dr Jamie Hagen. This report presents findings from research carried out by Mohaddeseh Ziyachi between July and September 2021. The next section outlines the purpose and procedure of this mapping exercise. Subsequently, the findings are categorised according to publication type (section 2) and authors' affiliation with Queen's university's schools (section 3). Section 4 provides a thematic summary of gender related research conducted at Queen's and includes a bibliography of the research categorised in this report.

The Centre for Gender in Politics serves the growing community of feminist scholars and activists in international studies who apply a gendered lens to understand challenges in global politics. Research conducted at the centre investigates the centrality of gender, in intersection with other categories such as race, class, sexuality and ability, in shaping local, national and global dynamics. Inspired by Cynthia Enloe's famous slogan "the personal is political, is international", we argue that these intersections matter in shaping the political, from everyday experiences to political institutions, from cultural production to "high-level" strategies for global security. ## 1. PROJECT PURPOSE AND PROCESS

The goal of this project was to gather a snapshot of gender research and publications at Queen's University Belfast. Three fundamental questions about available research items guided this mapping effort.

- · Who is doing the research?
- What type of research item is it? (article, conference presentation, book, et.)
- Where at Queen's is this research happening?

To begin answering these queries, the database of QUB Research Outputs on PURE was searched for relevant materials. In the first stage, and in order to obtain a thorough perspective, the database was searched for the following keywords:

Women/ men/ feminist/ feminism/ LGBT /masculinity/ femininity/ sexuality/ intersectionality/ gender/ gender roles/ motherhood/ maternity/ mothering/ fatherhood/ fathering/ manhood/ womanhood/ patriarchy

The search yielded more than 19000 results from a range of fields. Given that collecting and analysing this volume of research exceeded anticipated time and funding constraints, the search was reduced thematically to the keywords "gender" and "feminist," and temporally to studies completed in the last five years, from 2016 to the present. As such this report offers a snap shot of research conducted in a five year timeframe rather than a comprehensive analysis of all the existing research on this subject at QUB.

The search returned 153 items which met the defined criteria. All pieces are recorded in Zotero, a free and open-source reference management software. This archive contains information about each item, including its type, title, author(s), publication date, and URL, and is accessible to the public via the following link:

Among the results, several studies were not relevant to the project's objective. For example, some findings just included the search terms, without being particularly concerned with gender. To discover these cases, the title and abstract of each item was skimmed, and the keywords were searched in the text to investigate whether the research is focused on gender or not. Items deemed to be subjectively irrelevant, as well as posters, were eliminated from the archive. Ultimately, 100 items were retained, classified, and labelled, including journal articles, book sections, books, theses, and reports.

The remainder of this report presents an overview of this archive in terms of publication type, authors' affiliation at Queen's University, and thematic content of the research.


## 2. TYPE OF ITEMS

Out of the 100 recorded items, journal articles account for the largest share (74%). Book sections and conference papers come in second and third, with 10 and 6 percent, respectively.

Figure 1: Types of research items





## 3. AFFILIATION OF AUTHORS

Gender and feminism are two prominent areas of inquiry in a wide variety of research fields, and are no longer exclusively the domain of the humanities and social sciences. Hence, gender researchers are linked to a range of schools from the arts and humanities to science and engineering. As illustrated in the accompanying table and graph, scholars in the school of law have done the greatest number of studies on gender and feminism. The second and third places go to the School of Social Sciences, Education, and Social Work and the School of History, Anthropology, Philosophy, and Politics, respectively.

To define thematic tags for the recorded items, the title and abstract of each item were carefully read. Initially, 33 themes were identifies amongst the 100 research works. Then, comparable tags were merged into one label, decreasing the total number of tags to 14. These labels were later classified into broader categories. Finally, 6 major labels were specified, some of which containing sub-labels. The following table and graph illustrate these themes:



## 4.1. GENDER (IN)EQUALITY

This category of gender studies, encompassing 28% of found items, is broadly concerned with gender (in)equality, gender gaps or gender biases across a variety of disciplines and contexts. This collection of research can be divided into five sub-groups according to the research's primary objective:

### 4.1.1. EDUCATION AND SCIENCE

The largest number of studies in this category deals with the issue of gender inequality against women or gender gap in education, learning and science. They investigate gender imbalance in technical fields such as IT and architectural education, gender biases against women in sciences and mathematics, and gender differences/inequality in teaching and learning.

### 4.1.2. SOCIO-POLITICAL DISCOURSES

This second subcategory comprises research that examine gender inequality and biases against women in a variety of socio-political discourses. They look at anti-gender campaigns, gendered social discourses against mothers, and racist anti-Muslim discourses hostile to women.

The second recurring theme in the studies investigated for this research is the necessity and importance of employing a gendered perspective or having gender sensitivity. These studies, which comprise 28% of total items, can be further classified into the following categories:

# 4.2.1. GENDER SENSITIVITY IN CREATING LAWS AND POLICY MAKING

The bulk of studies in this group emphasise the necessity and importance of taking a gender perspective while developing foreign policy, making environmental, ecological, welfare, educational, and sexual policies, family planning, constructing post-conflict policies and programmes, and ratifying laws.




## LGBTQ+ RESEARCH AT QUEEN'S UNIVERSITY BELFAST

Figure 4: Affiliation of authors (schools)




