Conveyancing and Practice Management Seminar

Following last year's very successful seminar, the Institute of Professional Legal Studies is offering a new seminar on how practitioners can respond to current challenges in conveyancing practice.

This seminar will cover: the key areas of solicitors' liability re lenders and the CML Handbook; purchasing apartments; purchasing newly built dwellings; how to avoid cyber scams; implications of the updated flood plain map; ongoing Land Registry issues including positional improvement of maps; auction purchases; purchasing repossessed properties; and examining the current implications of the Law Society General Conditions of Sale.
