Pharmacy MPharm Pre-registration Year

All international students from outside the European Economic Area, graduating with an MPharm from a UK university, must apply for a visa in order to work in the UK i.e. undertake their pre-registration training. There are a number of different options for this –

The RPS <u>Pharmacy Professional Sponsorship Scheme (PPSS)</u> is open to graduates who started
their course on or before September 2011. The PPSS is jointly funded by all participating Schools
of Pharmacy (including Queen's); <u>the RPS does not charge students for participating in the
scheme</u>. In Northern Ireland, the Scheme operates in association with the Pharmacy Forum of the
Pharmaceutical Society NI.

Please note, the PPSS is an interim measure and does not cover pharmacy students who started their degree after September 2011.

Successful applicants to the scheme receive a Certificate of Sponsorship that is essential in order to apply for a Tier 5 visa for leave to remain in the United Kingdom.

From 2016, most overseas students will be expected to apply for a Tier 2 visa and will therefore only be able to undertake a pre-registration place with an employer registered as a <u>Tier 2 sponsor</u> and which pays the minimum salary to meet the Tier 2 requirements. These placements are open to all MPharm students (British, EU and overseas) and so competition for these placements will be very high. - 3. However, if you are a national of one of the following countries you may be eligible to apply for a 2-yr work visa under the Tier 5 Youth Mobility Scheme.

The scheme is also available to holders of British Overseas Territories passports and British Nationals (Overseas).

You cannot switch into this immigration category from within the UK. Instead, you need to leave the UK and apply for entry clearance.

- If you are from the Republic of Korea, you need a certificate of sponsorship in order to apply. You obtain this by contacting the Consular Services Division of the Ministry of Foreign Affairs.
- If you are from Taiwan, you need to register your interest with the National Youth Commission. Registration is usually only open for a short period each year. If the National Youth Commission accepts your registration, they will send you a certificate of sponsorship and details of how to apply for your visa.
- If you hold a Hong Kong (Special Administrative Region) passport, you need to apply to the Labour Department for a certificate of sponsorship.
- The Home Office website has full details about how to register if you are from the Republic of Korea, Taiwan or Hong Kong.

If you are from one of the other eligible countries or you have a British National passport, you are not required to register your interest and can just apply using your passport as evidence that you are sponsored. Places are, however, limited in number and your application will be refused if all the places for a year have already been taken. There is no limit for British Overseas Citizens, British Overseas Territories Citizens and British Nationals (Overseas).
