## 1. Invitation Paragraph

You are invited to take part in a research study by completing an online survey. It is important that you understand why the research is being done and what it will involve before you decide whether to take part. Please take the time to read the following information carefully and discuss it with others if you wish. Please ask us if there is anything that is not clear or if you would like more information.

#### 2. What is the purpose of the study?

This study is called 'Audit of impact and knowledge exchange opportunities using an online survey tool'. It involves participants completing an online survey. The survey is aimed at understanding the capacities, attitudes, and processes involved in sharing, discussing, or otherwise using the findings of social science research related to social aspects of energy transition.

#### 3. Why have I been chosen?

You have been invited to take part because we think you are work in an area that uses, or has the potential to use, the findings of social science research on the energy transition to inform your work or the work of your organisation.

#### 4. Do I have to take part?

No. It is up to you to decide if you wish to take part. If you decide to take part, you will be asked to give your consent to the answers you supply being used as part of a dataset for analysis. You can change your mind at any time and withdraw from the study without giving a reason. If you decide to do this before analysis of the data has begun, we will delete any record we have retained from your participation. If you decide to withdraw from the study after analysis has begun, we will delete your email address if you supplied it, but we will not withdraw your responses from the study: responses will be anonymised at that point, and it will be impossible to identify your from any output of the study that is released publicly.

#### 5. What will I have to do if I decide to take part?

If you wish to proceed with the survey you can proceed to follow the online links provided here, which will take you to a survey that will take no more than 20 minutes to complete. At the start of the survey, you will be asked to agree with the statements below, thereby giving your consent to take to the survey and allowing us to use the information you provide:

## 9. Will my taking part in this study be kept confidential?

Yes, your participation will be confidential and will not be associated with you. If you would like to hear about the results of the study, we will ask you to provide an email address, and this will be stored separately and not associated with the answers you provide in the survey.

After the survey closes, the data will be downloaded and deleted from SurveyMonkey – the deleted data is permanently removed from the system within 90 days. Before that, SurveyMonkey has a series of measures to ensure protection of the survey data (please see <u>here</u>).

Once downloaded, the dataset (without email addresses) from this study will be encrypted and held on the PI's password protected QUB OneDrive account, or a password-protected computer/drive, and will be shared within the research team. The research team in this study includes Early Stage Researchers at the University of St Gallen (Switzerland), IZES gGmbH (Germany), ISCTE (Portugal), and the University of Exeter (United Kingdom). These researchers will not have access to your email address and will not be able to identify you on any basis. A report of the study may be submitted for publication, but we analyse the data on an aggregate level, and no individual participants will be identifiable.

As noted above, the contact details (your email address, if you choose to provide it) will also be removed from SurveyMonkey and stored on the password protected QUB OneDrive account of the MISTRAL Project Manager, and permanently deleted once the research findings have been communicated (estimated to be not later than May 2021).

#### 10. What will happen to the results of the research?

The findings of the survey will be used to inform how social scientists can better communicate their research to those interests, such the private sector or policymakers. It may also provide insights on how non-academic interests can more effectively access external research. We will disseminate the findings through working papers, a lay-summary, academic partners and a webinar, to which you will be invited if you give us permission to do so.
