Student news:



Undaunted by the Friday 13 May date, students on the Recording History module attended BBC Radio Ulster to pitch a series of ideas for potential radio documentaries. The students were attempting to follow in the trail of Marty Delaney, Sara Gallagher and Ryan Mallon, who last year convinced the BBC production team that their idea 'Diamond in the rough' was fit to commission. It was broadcast in 2015 on Radio Ulster and on Radio 5 Live. This year, seven groups of students pitched their ideas to the BBC's Michael Tumelty (Head of BBC Radio Ulster/Foyle Factual), Regina Gallen (Producer, Radio Ulster/Radio 3), and Conor Garrett (Producer, Radio

Ulster/Radio 4). The students all did very well. The BBC's feedback was that this was the strongest group of pitches in the four years to date. 






In the course of a robust but engaging review of Professor Liam Kennedy's recent book, *Unhappy the Land*, in the Irish-American paper, the *Irish Voice*, Cahir O'Doherty wrote: "To authors like Tim Pat Coogan, Kennedy is simply a revisionist historian suffering from a poignant need to re-contextualize the subjugation of Ireland to make it less emotive and troubling, a sort of historical Stockholm syndrome that Coogan calls "colonial cringe."

New book published in **Series: Material Mediations: People and Things in a World of Movement**



Description of the series: During the last few years, a lively, interdisciplinary debate has taken place between anthropologists, art historians and scholars of material culture, religion, visual culture and media studies about the dynamics of material

production and cultural mediation in an era of intensifying globalization and transnational connectivity.

Understanding 'mediation' as a fundamentally material process, this series provides a stimulating platform for ethnographically grounded theoretical debates about the many aspects that constitute relationships between people and things, including political, economic, technological, aesthetic, sensorial and emotional processes.



Dr Fearghal McGarry has published *The 1916 Easter Rising*, an illustrated history commissioned by An Post to complement the release of its 1916-2016 centenary stamps.

Research projects and awards:

Former research fellows with the School of History and Social Anthropology, Dr Sean Lucey and Dr Brian Gurrin, have been appointed as research associates on the Leverhulme-funded Irish Famine project at Ulster University which is linked also to the Institute of Irish Studies, QUB.

Conferences, seminars and public lectures:

Professor David Hayton gave a paper entitled 'Lewis Namier: nationality, territory, and Zionism' to a conference organised by the Woolf Institute at Selwyn College, Cambridge on 20 May, on 'Jewish conditions, theories of nationalism'.

The British Academy has selected the conference proposed by Dr Todd Weir for its 2017 conference series. "Defending the faith: Religious and Secularist Apologetics in Twentieth-Century Politics" will bring together 16 international scholars to discuss the contribution of apologetics to the history of religious and political ideas in the twentieth century. Participants will include Professor Peter Bowler.

On 21 April, Dr Ida Milne and Fiona Clark hosted a talk (as leaders of the ICRH Framing Epidemics network) by travel business journalist Eoghan Corry a 'From A to Zika: epidemics, fear and lessons from history for modern travellers'. Corry spoke about the risks current and past emerging epidemics – zika, dengue, ebola, malaria and the 2009 Influenza A epidemic -- have posed to travellers, and the ensuing effects on the travel business.

The ICRH Framing Epidemics network held its final reading group meeting – led by Dr Ashok Maholtra - on Tuesday, 24 May.

The Wiles Colloquium, New Approaches to Public History, organised by Dr Olwen Purdue and Dr Leonie Hannan, was held on 12-13 May. This very successful event was attended by over 60 delegates from a range of academic, public history, government and third-sector organisations and generated a great deal of fascinating discussion around the

role and practice of collaborative public history particularly in contexts such as Northern Ireland. Speakers included Professor Ludmilla Jordanova (Durham); Professor Helen Chatterjee (UCL); Heather Thompson (Director of National Trust NI); Ben Cowell (Director, Historic Houses Association) and a number of academics from across Ireland including our own Dr Kieran Connell and PhD student Matthew Jackson. On the 12 May the School of History and Anthropology hosted 'Spyfest', an annual workshop set up by the late Professor Keith Jeffery eight years ago. Various speakers came to pay tribute to Keith including long-time collaborator and friend Professor Christopher Andrew and former PhD students Dr Emily Haire and Jonathan Best.

Dr Fearghal McGarry was an invited speaker at conferences on the Easter Rising hosted by Queen Mary University of London and Down County Museum. He also gave public lectures to mark the centenary of the 1916 Rising at North Down Museum, the Irish Embassy in Warsaw, the Catholic University of Lublin, the Tower Museum in Derry and Cavan County Museum.

Knowledge transfer / research impact:

Dr Anthony J. Stanonis presented on his new manuscript project at UCD on 17 May. The talk was entitled "Conjuring Rebellion: Voodoo in the American Imagination since 1804."

Professor Liam Kennedy was interviewed on Good Morning Ulster and Talkback, BBC, NI, on current levels of paramilitary violence in working-class communities in Northern Ireland. He also spoke to the Humanist Society, Northern Ireland on the Easter Rising.
